The City of Sidney, Nebraska, Public Services Department, in accordance with National Flood Insurance Program regulation 65.7(b)(1), hereby gives notice of the City's intent to revise the Lodgepole Creek floodway, generally located between Greenwood Road and Fort Sidney Road, the floodway shall be revised from a point 500 feet west of Fort Sidney Road to a point 1,500 feet directly downstream of Fort Sidney Road.
